### 2.1 Visa

### 2.2 Identity Card

Before travelling to Germany you need to have a current identity card if you are in the European Community otherwise you need a passport.

### 2.3 Further entry requirements

#### Advice for travelling by car:

1. blood alcohol limit while driving a car:
  - a. people under the age of 21 are prohibited to have any blood alcohol limit
  - b. all the other people are *allowed* to have a blood alcohol limit of 0,3 per mill, but you can still get into trouble, please don't drink and drive

2. speed limit:
  - a. city limit 50km/h if not marked otherwise
  - b. country road 100km/h if not marked otherwise
  - c. Autobahn no limit if not marked otherwise
  
3. it is necessary to be in possession of a valid driver license
  - a. either an international driver license or
  - b. a German driver license

#### Health:

No vaccinations are required for entry into Germany.

It is recommended to travel with international health insurance.

## DWWV QUALIFIKATIONSKRITERIEN CABLE WAKEBOARD & WAKESKATE 2012

Die Teilnahme an der letzten Deutschen Meisterschaft ist die Grundvoraussetzung für die Teilnahme an internationalen Veranstaltungen.

Für den Bereich Cable Wakeboard gibt es darüber hinaus weitere Qualifikationskriterien, die für den Bereich Cable Wakeskate nicht mehr gültig sind.

Für die folgenden Kategorien wird eine Mindestgrenze an Ranglistenpunkte aus der nationalen Rangliste für internationale Wettkämpfe verlangt, die am Wettkampftag erfüllt werden muss.

### Open Men, Open Ladies, Junior Men, Junior Ladies:

- mind. 100 Punkte zur Teilnahme an internationalen Wettkämpfen (3STAR Event)
- mind. 200 Punkte zur Teilnahme an einer internationalen Tour (4STAR Event)
- mind. 300 Punkte zur Teilnahme an Europameisterschaften (5STAR Event)
- mind. 400 Punkte zur Teilnahme an Weltmeisterschaften (6STAR Event)

Auf Grund von nur wenig stattfindenden Wettkämpfen auf nationaler Ebene müssen die Kategorien Masters Men / Masters Ladies, Veterans Men / Veterans Ladies, Boys / Girls, nur die Hälfte der jeweils nötigen Punkte erreichen.

Die Ranglistenpunkte müssen in der Kategorie vorhanden sein, in der man bei dem entsprechenden Wettkampf starten möchte.

**Zusatz:** Alle Kategorien (Nicht Open) müssen die doppelte Punktzahl in Ihrer eigenen Kategorie haben, um in der nächst höheren bzw. Open Kategorie starten zu dürfen!

Für die Teilnahme an einer EM oder WM in den Kategorien Junior Men / Junior Ladies und Open Men / Open Ladies muss außerdem mindestens ein Besuch eines internationalen Wettkampfes innerhalb der letzten 12 Monate erfolgt sein!

### Bemerkung:

Erfüllung der Qualifikationskriterien alleine reicht nicht zur Startberechtigung auf Internationalen Veranstaltungen aus. Es bedarf immer der Startgenehmigung des Vereins und des Verbandes. Für nationale Veranstaltungen bedarf es der Zustimmung und Meldung des Vereines.

Zur sicheren Reiseplanung wird die Startberechtigung für Internationale Veranstaltungen bei Erfüllung der Qualifikationskriterien spätestens 4 Wochen vor Veranstaltung erteilt. Auf Anfrage kann diese auch schon früher erteilt werden.

Die Startberechtigung kann aber jederzeit bei unsportlichem Verhalten (Definition siehe E&A und IWWF World Rules) oder bei Nichterfüllung der Qualifikationskriterien zurückgezogen werden. Dies ist auch noch am Wettkampftag möglich.

Diese Richtlinien und Qualifikationskriterien beziehen sich auf die normalen vom IWWF bzw. DWWV registrierte Veranstaltungen (z.B.: EM, WM, CWWC). Die Teilnahme an Top Level Veranstaltungen wie den World Games, Mediterranean Games oder der Universiade sind den Kaderläufern des DWWV vorbehalten.

Ausnahmen sind auf Antrag an das DWWV Ressort Wakeboard und Wakeskate möglich. Aktuelle Teilnahmebedingungen können beim DWWV Ressort Wakeboard und Wakeskate erfragt werden.

With the participation the runners do without any demands of requirements from all cases of damage, which result directly or indirectly from the meeting. All participants must be liabilityinsured accident - and/or. The requirements of the condition and the safety precautions of the match distances depend on the valid in each case regulations of the international water ski and wakeboard federation (IWWF) region EA, the national water ski federation (ÖWWV), the valid in each case regulation and delivering mode of the ÖWWV and the valid in each case agreement (product requirement specifications) between the organizing committee and the ÖWWV, whereby the arrangements of the respective arbitrator are determining. Each participant commits itself to speak own objections the arbitrator. With his start the fighter gives to recognize that the given condition of the match distance and existing safety precautions are suitable as and are sufficiently recognized. An adhesion for a certain condition of the competition distance or certain safety precautions, going beyond that, does not take over the organizer.
